We have close cooperation with our foreign colleagues, providing good opportunities for international collaboration within the organization. **As a software developer, your primary tasks will consist of:**

- Development of robust and scalable solutions in .NET with a focus on automation and system integration
- Implementation and technical upgrade of Microsoft Dynamics 365, including adaptation and further development of CRM functionalities
- Close collaboration with the business on needs assessment, solution design and delivery of development tasks
- Maintenance and further development of our React-based sponsor platform with a focus on
